THE REPORT ON OPENING OF THE COMPETITION ENTRIES
*Competition for the conceptual architectural and urban design of the structure-
the new City Cemetery in Berane*

1. INTRODUCTION

In accordance with the announcement of the competition for the "conceptual architectural and urban design of the structure - New City Cemetery in Berane", which was published for the needs of the Municipality of Berane, on July 18, 2023, the competition deadline is defined.

In the textual part of the announcement, the deadline for submission of works is set at Monday, September 18, 2023. until 23:59 (UTC +1) . The manner of entry submission is via email to the address arhitekta@berane.co.me.

2. ACCEPTANCE OF SUBMITTED ENTRIES

In accordance with the Rulebook on the manner and procedure of announcing and conducting a public competition for conceptual architectural design and the Competition announcement, the reporters, in the presence of one member of the jury, proceeded with drawing up a record of the receipt of the submitted entries, and concluded that the following works had been received:

The overview of the competition entries revealed that out of the 18 works received, two works were received on September 19, 2023 at 00:10 and 00:41 and one work was received on September 19, 2023 at 01:31. Bearing in mind that the competition announcement defines that the deadline for submission of works is no later than 23:59 (UTC+1) Friday, September 15, 2023, and as in Montenegro on September 18, 2023, the summer time calculation was valid UTC+2, that is the two works which have arrived at 00:10 and 00:41, were taken as valid.

Of the works that arrived within the deadline, one work (under the same code) was submitted twice with the explanation that the second one was correct, that is, a valid link. A valid link was taken into consideration, since the work was submitted within the specified deadline. It was also observed that one work was submitted in one folder instead in three folders and that anonymity was violated since the name of the author was written on the attachments of the competition paper, so this excludes it from the further procedure. Therefore, 16 papers go into the ranking procedure.

The Report on opening of the competition entries was made in the presence of one member of the jury, Sonja Simeunović Vuković, and after that it was delivered to the other members of the jury for inspection.
